WHO Health Tech Announcements January 2019 newsletter on medical devices

1. 4th WHO Global Forum on Medical Devices, December 2018

The Fourth WHO Global Forum on Medical Device (4GFMD) "Increasing access to medical devices", was successfully held from 13-15 December 2018, at the Andhra Pradesh MedTech Zone in Visakhapatnam, India. The programme included over 200 presentations on topics ranging from medical devices classification and nomenclature (ICMD) to the WHO Essential in vitro Diagnostic List (EDL), Priority medical device (PMD) to Oxygen delivery systems, besides regulation, assessment, procurement, innovation, among other topics. The event was attended by representatives of WHO, as well as senior Indian government officials from India, and had over 1000 participants from 92 countries. The evaluation and final report are in process.

2. WHO Executive Board meeting 2019

The 144th Executive Board meeting took place from 24th January to 1st February. The Executive Board is composed of 34 technically qualified members elected for three-year terms. https://www.who.int/mediacentre/events/governance/eb/en/

Important topics were discussed as: patient safety, access to medicines, vaccines and health products (which specifically addresses medical devices), cervical cancer, ICD11, ... and these will be presented in the World Health Assembly in May. https://www.who.int/news-room/events/executive-board-144th-session

During this Executive Board meeting 71 NGOs were approved to continue as Non-State Actors in official relations with WHO for 3 more years. Among them: IFCC, IFBLS, IFHE, IFMBE, ISR, ISRRT, IUA, WASPALM and WFUMB; besides, WFBMB (World Federation of Nuclear Medicine and Biology) was approved for the first time. 3. WHO: Essential in vitro Diagnostic List (EDL)

It is expected that the EDL will provide guidance and serve as a reference to Member States and other parties involved in developing and/or updating lists of national essential IVDs (In vitro diagnostics) and/or medical devices, and selecting and implementing such IVDs.

The Strategic Advisory Group of experts for IVD will meet 18 to 21 March 2019 to recommend the tests for the second edition of the EDL.

An open session with all stakeholders will take place 18 March 2019. A link to register, and information on the tests to be discussed, will be available by 18 February.

4. Classification and Nomenclature of Medical devices

The nomenclature of medical devices is a coding system used to generically identify medical devices and related health products.

Having a nomenclature system in place for medical devices facilitates their management and regulation by standardizing terms that enable communication despite linguistic and other barriers.
