Call for 2022 Awards Nominations

The International Federation for Medical and Biological Engineering is seeking nominations for several 2022 awards. Award recipients will be honored at the World Congress on Medical Physics and Biomedical Engineering to be held in Singapore, from June 12 - 17, 2022. Introduction

The International Federation for Medical and Biological Engineering (IFMBE) recognizes the Biomedical Engineering professionals for their contributions to the Biomedical Engineering field. The awards are generally presented every three years on the occasion of the World Congress. The newest edition of the awards will be presented to the awardees in conjunction with the World Congress 2022 to be held in Singapore next year. There are currently numerous awards: the Zworykin Award, named after the IFMBE Founder President Professor V. K. Zworykin; the Otto Schmitt Award; the John A. Hopps Distinguished Service Award; and the Laura Bassi Award. Nominations for the awards are sought from all IFMBE constituent societies (national and transnational member societies). The review for nomination and the selection of the awardees are made by the IFMBE Awards Committee. The selected nominees are reviewed by the IFMBE Administrative Council for approval.

IFMBE recognizes distinguished biomedical engineers for their contributions of many years standing by granting the status of IFMBE Honorary Life Member

In addition to its own awards program, IFMBE also participates in the IUPESM awards program. IUPESM honors individuals with its IUPESM Awards of Merit which recognize every three years a Medical Physicist and a Biomedical Engineer who have established distinguished careers in Medical Physics and Biomedical Engineering, respectively. The IFMBE Awards Committee acts as IFMBE Sub-committee to the IUPESM Awards Committee and is responsible for the selection of the Biomedical Engineer to be awarded.

IFMBE also awards the winners of competitions organized as part of the World Congress and selected scientific events in the period between the congresses:

Young Investigators Competition, Scientific Challenge Competition and Student Design Competition.

The IFMBE supports the IAMBE Early Career Award in recognition to BME researchers at an early stage in their career.

Both IFMBE divisions, the CED and the HTAD awards professionals from their fields of expertise.

IFMBE Awards and Recognitions

Vladimir K. Zworykin Award

The Vladimir K. Zworykin Award is given to a Biomedical Engineer for outstanding research contributions in the field of medical and biological engineering. The criteria for nominations include innovation and outstanding research contributions to medical and biological engineering. The awardee will receive prize money of 2500 euros as well as travel funds to attend the World Congress 2022 in Singapore where the award will be presented. The awardee will be required to make a scientific presentation in the area of the awardee's expertise at the World Congress.

Otto Schmitt Award

The Otto Schmitt Award is given to a Biomedical Engineer for exceptional contributions to the advancement of the field of medical and biological engineering. The criteria for nominations include leadership and seminal contributions to medical and biological engineering. The awardee will receive prize money of 2500 euros as well as travel funds to attend the World Congress 2022 in Singapore where the award will be presented. The awardee will be required to make a scientific presentation in the area of the awardee's expertise at the World Congress.

John A. Hopps Distinguished Service Award

The John A. Hopps Distinguished Service Award winner is given to a Biomedical Engineer who has made significant contributions to the professional, technical, promotional, educational and/or scientific activities of the IFMBE, or of a regional organization of societies affiliated to the IFMBE. The awardee will receive prize money of 2500 euros as well as travel funds to attend the World Congress 2022 in Singapore where the award will be presented. The awardee will be required to make a presentation on the awardee's contributions to IFMBE and BME at the World Congress.

Laura Bassi Award

The Laura Bassi Award is presented by IFMBE every three years at the World Congress. The award is given to a female Biomedical Engineer for outstanding research contributions in the field of medical and biological engineering. The criteria for nominations include leadership and seminal contributions to medical and biological engineering. The awardee will receive prize money of 2500 euros as well as travel funds to attend the World Congress 2022 in Singapore where the award will be presented. The awardee will be required to make a presentation in the area of her expertise at the World Congress.

IUPESM Awards of Merit

The IUPESM Awards of Merit (Biomedical Engineering) is given to a Biomedical Engineer who has made significant impact in the science and scientific practice of Biomedical Engineering. The awardee would have participated meritoriously in national and international organizations for Biomedical Engineering and have significantly influenced the development of the profession of Biomedical Engineering. The awardee will receive prize money of 2500 euros as well as travel funds to attend the World Congress 2022 in Singapore where the award will be presented. The awardee will be required to make a presentation on the awardee's scientific and professional contributions to BME at the World Congress.

Nomination Requirements

Nominations may be made by IFMBE entities, affiliated member societies, or a group of at least five distinguished IFMBE members. Nominees must be members of an IFMBE affiliated organization. A Curriculum Vitae is to be submitted together with a half-page biography, a photo, and a one-page write-up on the significant contributions made in relation to the specific criteria for the award for which nomination is made.

Young Investigators Award

The IFMBE Young Investigator Competition (YIC) is organized annually to recognize excellence in conference contributions whose primary authors are young investigators (persons under the age of 35). Ten finalists of the YIC will be announced before the beginning of the Congress and based on the evaluation of presentations of their research at the Congress, the YIC committee will decide on the competition winners. The awardees in 2022 will receive prize money as well as funds to support their attendance at the World Congress 2022 where the award will be presented.

IFMBE Scientific Challenge

In this edition of the IFMBE Scientific Challenge participants are asked to find the best solution for a defined problem in biomedical and health informatics. To participate as an individual or collective team, the participant(s) should register in the challenge to have access to the dataset for the competition and prepare a full paper for publication in the congress proceedings. The finalists will present their solutions and the best three solutions to the challenge will be awarded at the Congress.

Student Design Competition IFMBE Toh Siew-Lok BME Design Award

The focus of the competition is on the design of a low-cost medical device to improve healthcare in resource-scarce communities. The finalists will present their solutions and the best three solutions to the challenge will be awarded at the Congress.

The IFMBE-IAMBE Early Career Award (ECA) highlights the commitment of the IFMBE and IAMBE to support and encourage promising young researchers at an early stage in their career. The Award consists of a certificate and a monetary award. Awards are given at each IUPESM World Congress to one individual from each of the following four geographic regions: North America, Central & South America, Europe & Africa, and Asian-Pacific. Particular emphasis is given to countries with a low economic background and to geographical diversity.

Best Clinical Engineering Article and Conference Paper Award

This award specifically aims to encourage the development of clinical engineering as an academic discipline within biomedical engineering.

The IFMBE-WHO Innovative HealthTech Awards

The World Health Organization (WHO) and IFMBE with support of the IFMBE Clinical Engineering Division (CED) made a joint effort to identify innovative health technologies designed and developed by students, researchers, and inventors. There are 4 awards that promote innovative health technologies that address global health concerns that are to be designed, developed, and be affordable for low-resource settings. The intent is to discover promising innovations that can be used to help people in countries that cannot afford to purchase and maintain expensive technologies. The

IFMBE and WHO are offering the following 4 prizes: Best Medical Device Innovation, Best Digital Health Innovation, Best Healthcare Methodology Innovation and Best Clinical Engineering Innovation. Besides receipt of awards, the innovation will be included in the WHO compendium series.

IFMBE / BIOMAG Awards

James Edward Zimmerman Prize

Award presented for exceptional contributions to the development of new methods in biomedical engineering. The primary criterion for the JZP is a significant contribution to novel SQUID-based and new generation of sensor developments, and applications in the field of biomagnetism. The award is presented biannually either at the BIOMAG Conferences or during the Biomagnetism Session of the World Congress with a monetary award of 1,000 EUR. The IFMBE would contribute to travel expenses and ask the WC organizers to waive the registration fee for the World Congress. The JZP winner is expected to give an oral presentation of the awarded research during a plenary session.

Nominations for the Award are processed by the organizers of BIOMAG events.

MBEC Awards

MBEC Nightingale Award

Alfred Nightingale was editor of the International Federation's Journal, now published as "Medical and Biological Engineering and Computing" (MBEC). In his memory, a prize was initiated, and it is awarded yearly by the Institute of Physics & Engineering in Medicine and the IFMBE for the best paper in the Federation's Journal. The prize, EUR 500, shall normally be made annually for the best scientific paper published in each volume of the Journal and awarded jointly to the research team.

MBEC Citation Award

The MBEC Citation Award is presented to author('s) of the paper published in the MBEC volume three years ago with the most citations in two subsequent years. The Citation Award to be presented at the World Congress 2022 will be for a paper published in 2019.

MBEC Award for a Young Paper Author

The Award is aimed for the author(s) of the best scientific paper published in the Federation's Journal by a young first author who made the essential contribution to the publication. The prize, EUR 250, shall normally be made annually for the paper published in the previous year volume of the Journal and shall be awarded to the first author.

Nominations for all MBEC Awards are processed by the IFMBE Federation Journal Committee.
