Martha Lucía Zequera Díaz, PhD, is a Full Professor at the Pontificia Universidad Javeriana, Bogota, Colombia and an expert in biomedical engineering, with over 24 years of experience in research, education, and technological innovation. She obtained her PhD in Bioengineering from the University of Strathclyde and a Master's degree in Biomedical Engineering from the University of Dundee. Her expertise and achievements allowed her to build global networks and lead award-winning innovative projects in the field of digital health. Throughout her career, she has created a series of 9 Summer Schools on emerging technologies in health, impacting over 500 young people in Latin America and fostering interdisciplinary collaboration at conferences of IFMBE, IEEE-EMBS, and CORAL since 1998. As the Chair of the IFMBE Education and Accreditation Committee, she works in integrating education, research, and innovation, aligning them with global health challenges. With a vision to strengthen international representation, promote inclusion and diversity, and position IFMBE as a global benchmark in bioengineering, Dr. Zequera is dedicated in finding innovative solutions which could help in the attempt of transforming lives and address global health challenges through emerging technologies.
