Brief Biography of Nominee (not to exceed 200 words)

Giuseppe Fico is Associate Professor of Biomedical Engineering at Universidad Politécnica de Madrid (UPM), head of the health area at Life Supporting Technologies group at UPM and affiliated researcher and at the Group of Surgical Research Innovation at Health Research Institute of the Hospital Clínico San Carlos, Madrid, Spain. He is President Elect (he will be President since 25 March 2025) of the European Alliance of Medical and Biological Engineering, Spanish Ambassador of the Hospitals on FHIR initiative with HL7 Europe, former co-chairman of the Working Group on Health of the Alliance for Internet of Things Innovation, coordinator of the Adherence Action Group at the European Innovation Partnership on Active and Healthy Ageing. He is Technical Manager of the Flagship European Large Scale Pilots [ACTIVAGE](#), [GATEKEEPER](#), [ODIN](#) to demonstrate the impact of AI, Robotics and IoT technologies to create a new generation of digital health platform for chronic diseases, healthcare services, active and healthy ageing. He is coordinator of the IHI projects [BEAMER](#) and [IMPROVE](#), where digital tools are built for adherence to treatment and for the role of PROMs and PREMs in disease management. He is lecturer of >10 courses in Biomedical and Telecommunication Engineering at UPM, invited expert in international conferences from different scientific and industrial societies, in summer schools, and for certified training to healthcare professionals and managers.

He is also Associated Editor for several scientific journals, including the IEEE Journal of Biomedical and Health Informatics, Frontiers in Digital Health and computational and structural biotechnology journal smart hospital.

His research interests, as reflected in his extensive list of publications (including book chapters and numerous articles in indexed journals and conference proceedings), encompass eHealth, Health Technology Assessment, Human Computer Interaction, Clinical Decision Support Systems (DSSs), Artificial Intelligence (AI) and Machine Learning (ML) applied to Diabetes, Cancer Research and Personalized Medicine, Chronic Diseases, Active and Healthy Ageing, and Hospital Process Management.

Dr. Fico has also been involved in knowledge transfer activities, including his role as a founding member of ACTIVAGE.ORG and through various consultancy and training contracts with companies and research institutions. He has been an invited expert and keynote speaker at numerous international conferences and workshops.

Since 2015 he is an official collaborator of the HTA, CE Division of the IFMBE and since its creation is part of the Digital Health Division, currently organizing the first conference in Europe about Biomedical and Health Informatics (ICBHI).
