Brief Biography of Nominee (not to exceed 200 words)

Leandro Pecchia is Chair of Biomedical Engineering at the University Campus Bio-Medico (UCBM) in Rome, Italy, of the "Intelligent technologies for health and wellbeing" Lab and Director of the "Institute for Science and Technology for Global Health". The Italian Minister of Health appointed Prof Leandro Pecchia as medical device expert of the Technical and Clinical Committee of the Ministry of Health. From 2020 to 2023, he worked as Innovation Manager for the World Health Organization (WHO), Emergency program (WHE) Infection Prevention and Control (IPC) unit. Prof Pecchia is leading several research projects (GATEKEEPEP, ODIN, Afya Moja, ENKORE, GRACE, EPoCA) and coordinate the re-writing of WHO policy books on Medical Devices and medical devices donation.

Prof Pecchia authored more than 200 peer-reviewed papers in the fields of Artificial Intelligence, medical devices, biomedical signal processing, Health Technology Assessment (HTA), and IoT applied to active and healthy ageing and management of chronic diseases.

Prof Pecchia is the Secretary General of the <u>IFMBE</u> and Past President of <u>EAMBES</u>). He served the international community of biomedical engineers as Secretary General (2018-22) of <u>IUPESM</u>, Treasurer (2018-25) of the <u>IFMBE</u> <u>Clinical Engineering Division</u>, and <u>IFMBE Healthcare Technology Assessment Division</u> Chair (2015-18) and Treasurer (2012-15).

During my mandate, I will strength the relations among IFMBE and global policy makers, such as WHO, as I did with European Institutions when I was EAMBES President. We have to be sure that BME get the same level of recognition globally, working with the WHO, and in each continent, working with local governments. As IFMBE SG, I will do my best for replicating in each and every IFMBE Region the same level of support for policy-making. I will particular focus on LMICs. Many of my current projects are focused in Africa, aiming at strengthening capacity of local BME community for better engaging with the global one (e.g., <u>Afya Moja</u>, <u>EPoCA</u>). I will support other regions in need of support, to strength their position in IFMBE and in global policy making concerning health and health technologies.
